Major Modification to Development Plan Application Requirements

This checklist is intended to assist in preparing a complete plan that will address all City development standards, requirements, and review criteria. The following information must be included with the plan submittal. If justified, the City may except any requirement. The Land Use Review Division may require additional information in accordance with City Code Section 7.5.403 All documents should be neat and legible; inaccurate, incomplete, and poorly completed documents may be rejected.

	Modification Plan Set A modification plan set includes only the most recently approved plan sheets which clearly identify the portions of the plan proposed to be modified with easily recognizable "clouds" and/or applicable notes. Since the minor modification will replace the formerly approved plan, the final submittal for stamped approval must include all previously approved, as well as the modified plan sheets together as a complete plan.

Major Modification to Development Plan Application Requirements

Review Criteria

UDC 7.5.516.D(1) (Major Modification)

A Major Modification may be approved if the applicable decision-making body determines that the request:

- a. Complies with the provisions of the UDC and all applicable City regulations;
- b. Is consistent with any conditions in the approval or permit proposed to be modified, unless the decision-making body that imposed that condition modifies that condition;
- c. Does not create more adverse impacts on surrounding properties than the development approval or permit proposed to be modified; and
- **d.** Is consistent with the Colorado Springs Comprehensive Plan, other plans adopted by City Council, and the intent of the zone district in which the property is located.
