<p>The purpose of this position is to develop and modify Business and GIS software application programs of a moderate degree of complexity and scope, considering the computer equipment capacity and limitations, operational support needs, business requirements, and IT architecture standards. With general supervision, designs, configures, codes, tests, debugs, and documents custom-built software programs and interfaces. Participates in problem analysis and system design preparatory to development and modification of software programs. Competent to work at all phases of applications programming and workflow design activities. Adheres to and reinforces all IT policies, processes, and procedures using the ITIL framework.</p>
