### Class Specification – Fleet Technician

**Summary Statement:**

The purpose of this position is to provide body, glass, paint repair, and wiring services to all fleet equipment. This is accomplished by providing estimates and necessary repairs on units involved in collision or minor damages and normal wear and tear, installing different beds and aftermarket items, installing emergency lights or advisory lights and equipment, prepping and painting, suspension frame repair, and interior and upholstery repairs. Other duties include ensuring safety, customer care, service and communication, and continuing training and education.

<b>Essential Functions</b>	Note: Regular and predictable attendance is an essential function in the performance of this job.
<b>Time %</b> <small>(All below must add to 100%)</small>	Note: Time spent on each essential function will vary based on operational needs and is only intended to be an approximation over the course of a full year.
70%	Repairs, cleans, replaces, installs and modifies defective, missing, or malfunctioning components of mechanical, hydraulic, fuel, electrical, braking, steering, pumping, and other related systems of assigned vehicles and heavy equipment. Performs a wide range of automotive inspection, maintenance, and repair duties; modifies, tears down, repairs and reassembles major automotive components and assemblies including gasoline engines, automatic and standard transmissions, differentials, and front-end assemblies.
15%	Operates a variety of vehicles and equipment to test completed repairs, verifies existence of reported malfunctions and moves vehicles to needed locations within the service area. Installs a variety of parts and equipment on assigned vehicles including lights, trailer hitches, and generators. Operates a mobile repair vehicle to perform needed repairs and maintenance in the field; lubricate, repair and/or diagnose malfunctions of vehicles.
15%	Calculates an accurate cost estimate of repair work as assigned including labor, supplies, and parts costs. Ensures that all work activities adhere to all applicable federal, state, local, industry safety standards, and emissions mandates.
