Class Specification – Engineer II

Summary Statement:

The purpose of this position is to review, design, oversee, and coordinate a variety of transportation and engineering projects within the Public Works Department including financial administration, planning, design, budgeting, purchasing, and construction management; directing the work of outside engineering consultants involved in the construction, repair, and design of a variety of projects including sidewalks, streets, storm sewers, and other improvements; and to perform a variety of professional and technical tasks in support of assigned area of responsibility.

DISTINGUISHING CHARACTERISTICS:

These engineers appropriately apply engineering principles and concepts. Able to draw solutions from both formal training and experience.

Essential Functions	Note: Regular and predictable attendance is an essential function in the performance of this job.

90%	Performs civil engineering calculations and design reviews; reviews Engineering plan submittals per City criteria; prepares technical reports, plans, specifications, and cost estimates; participates in public meetings with stakeholders; and research right of way and property ownership.
10%	Performs a variety of project activities including the preparation and review of construction contracts, conduct pre-construction conferences, approves schedules, and reviews and approves pay requests and construction plans.

Reading: Advanced - Ability to read literature, books, reviews, scientific or technical journals, abstracts, financial reports, and/or legal documents. Ordinarily, such education is obtained at the college level or above. However, it may be obtained from experience and self-study.

Math: Advanced - Ability to apply fundamental concepts of theories, work with advanced mathematical operations methods, and functions of real and complex variables. Ordinarily, such education is obtained at the college level or above. However, it may be obtained from experience and self-study.

Writing: Intermediate - Ability to write reports, prepare business letters, expositions, and summaries with proper format, punctuation, spelling, and grammar, using all parts of speech. Ordinarily, such education is obtained in high school up to college. However, it may be obtained from experience and self-study.

Education: Bachelor's degree from an accredited college or university with major coursework in civil engineering or related engineering field.

Experience: Three years of full-time professional engineering experience in area related to assignment.
