Summary Statement:	
The purpose of this position is to lead strategic oversight of staff responsible for digital communications, media relations, public information and marketing functions for City programs and operations; and perform a variety of technical tasks relative to assigned areas of responsibility.	
Essential Functions	Note: Regular and predictable attendance is an essential function in the performance of this job.
Time % (All below must add to 100%)	Note: Time spent on each essential function will vary based on operational needs and is only intended to be an approximation over the course of a full year.
45%	Leads plans and reviews the work of staff responsible for digital and traditional communications and marketing for City programs and operations and messaging. Plans, directs, and participates in a wide variety of community special projects including the municipal and strategic planning programs, City sponsored events, reporting projects, and a variety of community involvement activities. Verifies the work of assigned employees for accuracy, proper work methods, and techniques and compliance with applicable standards and specifications.
30%	Coordinates media marketing and freelance programs; selects and hires freelance writers, photographers, and graphic artists; and coordinates activities in support of the assigned program. Consults with staff account representatives to determine budget availability for technical upgrades and media activations; and develops projects and suggests communication methods. Provides professional public relations, marketing, crisis communications, and strategic communication management in support of various City services; elected officials; enterprises and more to a broad range of internal, local, regional, national, and international audiences.
25%	Actively works to keep the city's communications vehicles and strategies up to date with market trends and technology.

Human Collaboration Skills: Decisions regarding interpretation of policies may be made. Contact may involve support of controversial positions or the negotiation of sensitive issues or important presentations. Contacts may involve stressful, negative interactions with the public requiring high levels of tact and the ability to respond to aggressive interpersonal interactions.

Reading: Advanced - Ability to read literature, articles, reviews, and social media or digital articles. Ordinarily, such education is obtained at the college level or above. However, it may be obtained from experience and self-study.

Advanced Skills and Knowledge: Work requires advanced skills and knowledge in approaches and systems, which affect the design and implementation of major programs and/or processes organization-wide. Independent judgment and decision-making abilities are necessary to apply technical skills effectively.

Relevant Background and Formal Education: Demonstrated skills, competencies, and knowledge required for this job are most often acquired through the following practical experience and level of academic education and training as suggested below.

Education: Bachelor's degree from an accredited college or university with major coursework in communications, journalism, public relations, or a related field.

Experience: Five years of full-time responsible public relations, communications, or marketing experience.
