

COLORADO SPRINGS MUNICIPAL COURT SCHEDULE OF FINES AND BAIL

(PAYABLE & NON-PAYABLE / TRAFFIC & NON-TRAFFIC)

The attached schedule of payable & non-payable violations is issued pursuant to City Code Section 11.2.103c is effective the 18th day of July, 2019.

This schedule supersedes all previous schedules for these code sections issued by this Court.

This is now the valid schedule for fines and bail for Traffic & Non-Traffic violation sections of the Code of the City of Colorado Springs, 2001, as amended.

Additional costs may be assessed administratively by the clerk or by the judge in the courtroom, and may include one or more of the following:

| \$20.00 | A pedestrian safety program funding fee shall be assessed on all convictions resulting from the issuance of a summons and complaint alleging a municipal traffic violation of this chapter, excepting articles 11 through 16 and 25 of Chapter 10 relating to parking violations. (See Section 10.24.101C) |
| \$5.00 | An Information Technology surcharge shall be assessed on all convictions resulting from the issuance of a summons and complaint alleging a violation of a city ordinance, excepting articles 11 through 16 and 25 of Chapter 10 relating to parking violations. (See Section 1.1.201G) |
| \$40.00 | Warrant costs are assessed by the Court for each warrant ordered and issued. |
| \$30.00 | Outstanding Judgment/Warrant (OJW) is assessed by the State of Colorado on traffic violations in which a warrant has been ordered and issued, and the defendant possesses a Colorado driver's license (CRS Ch. 42) and/or Juvenile Violations in which a warrant has been ordered and issued. |
| \$25.00 | Minimum Court Costs |

PLEASE NOTE: FINES FOR VIOLATIONS OCCURRING IN MARKED SCHOOL ZONES OR CONSTRUCTION ZONES WILL BE DOUBLED.


At or after first appearance, the general penalty section applies as provided in section 1.1.201 of the Colorado Springs code. Individual trial judges remain free to assess fines and sentence those convicted of these ordinance violations as they individually deem appropriate, given the specific circumstances of the offense and individual.

Any juvenile offender convicted of a violation of this Code, or any promulgated rule or regulation, shall be punished by a fine of not more than five hundred dollars (\$500.00), or by a sentence of probation, or by a combination of a fine and a sentence of probation. Jail is not a potential penalty for Juvenile offenders.

Any cash bond posted may be forfeited or applied to fines and costs imposed.

This schedule shall be posted in a conspicuous public place and distributed to judges, police departments and interested parties.
