Summary Statement: The purpose of this position is to perform a variety of complex clerical duties in the City Clerk’s office.	
Essential Functions	Note: Regular and predictable attendance is an essential function in the performance of this job.
Time % (All below must add to 100%)	Note: Time spent on each essential function will vary based on operational needs and is only intended to be an approximation over the course of a full year.
40%	Process licensing paperwork and payments; prepare various reports, memoranda, and correspondence for the City Clerk’s Office; maintain electronic and paper business license files; and assist with licensing activities for the City Clerk, including collection of required insurance forms, bonds and other required documents.. Thoroughly review and investigate complex applications including background checks and financial information. Review and approve licenses as applicable.
60%	Interact with internal and external stakeholders including the public; and serve as a liaison with other City departments, divisions, and outside agencies representing the City Clerk. Communicate frequently with licensees regarding application process and license compliance with City Code and State regulations. Perform off-site compliance checks and actively monitor any conditions imposed upon a license.

Competencies Required:	
Human Collaboration Skills: Decisions regarding implementation of policies may be made. Contact may involve support of controversial positions or the negotiation of sensitive issues or important presentations. Contacts may involve stressful, negative interactions with the public requiring high levels of tact and the ability to respond to aggressive interpersonal interactions.
