<b>Summary Statement:</b>	
The purpose of this position is to receive, review and distribute work orders for the City of Colorado Springs' Facilities department. Inputs and maintains work orders in support of internal personnel and their needs; supports supervisors with assigning work and maintains communication with internal and external customers on the timeline of work orders.	
<b>Essential Functions</b>	Note: Regular and predictable attendance is an essential function in the performance of this job.
<b>Time %</b> (All below must add to 100%)	Note: Time spent on each essential function will vary based on operational needs and is only intended to be an approximation over the course of a full year.
55%	Receive, track and review all incoming and outgoing work orders. Input and extract work orders from Cartegraph. Allocate work to respective facility maintenance supervisor or technician.
25%	Serve as a liaison between City Facilities and the other city departments. Communicate expectations of when work orders will be completed; ensure customers comprehend work order timelines. Communicate through phone, email or in-person interactions with supervisors, customers and stakeholders.
20%	Track workload of City Facilities and the work orders. Ensure work is being completed within agreed upon timetables.
