**Class Specification – Senior Code Enforcement Officer**

<b>Summary Statement:</b>	
<p>The purpose of this position is to perform lead complex, difficult, sensitive, and land use/zoning investigations; responsible for management and outcomes of special projects or programs; support and mentor Code Enforcement Officer ; train new employees; develop and deliver public presentations; and may be called upon to fill in for Code Enforcement Supervisors on a temporary basis during Supervisor absences. Perform field inspections and administrative support in the investigation of complaints and violations of land use, property maintenance, zoning, housing, and environmental safety ordinances of the City of Colorado Springs. Senior Code Enforcement Officers have the authority to order the compliance, abatement, discontinuance, removal, or alteration of conditions, which violate city codes, ordinances, and regulations. Employees in this position must independently manage a high-number of active cases; maintain extensive public contact; and thoroughly document daily activities in written logs, computerized case management systems, and other data systems. Issuing summonses and court testimony; unpermitted sign removal; code analysis, interpretation, and application; effective communication in person, in writing, by phone; and independent decision making are all integral elements for success as a Senior Code Enforcement Officer.</p>	
<b>Essential Functions</b>	Note: Regular and predictable attendance in the performance of this job is an essential function.
<b>Time %</b> (All below must add to 100%)	Note: Time spent on each essential function will vary based on operational needs and is only intended to be an approximation over the course of a full year.
30%	Investigate and identify land use and zoning violations, unlawful accumulation of solid waste, garbage, and yard waste by taking necessary measures. Investigate noise complaints reported in the residential areas; unlicensed storing of motor vehicles on private property; tall weeds and grass on private property; ensure obstacles are not placed on City rights of ways such as sidewalks and parkways; and removal any signs illegally posted on City property.

20%	Perform inspections of public and privately owned residential buildings to assure that they meet the housing standards by collaborating with housing community and managers; conduct physical inspections of routine housing complaints; conduct emergency inspection of sewage overflows and numerous other sanitary violations; and investigate insect infestations.
20%	Investigate whether the items are built in the right-of-way requiring a revocable permit; removal of illegal signs, communicate with the owners of the properties; investigate complaints regarding the use a recreational vehicle as a dwelling unit; coordinate with the owner and the planning department to confirm the existence of a home occupation permit; and ensure commercial properties are complying with lighting and development plan standards; and protect the natural growth and topography in designated areas of the city.
15%	Work high profile cases that require additional scrutiny and follow up; act as a resource for technical assistance to other code officers; maintain uniforms, patrol vehicles and equipment; prepare and deliver presentations for public meetings; complete offense reports; and photograph violations and attaches them in digital form to case reports.
10%	Tow vehicles that are a violation; coordinate with human society on animal welfare cases; and coordinate with internal departments and outside agencies. Lead, manage, and direct special projects or programs; train new employees; and provide temporary coverage during Code Enforcement Supervisors absences.
5%	Assist problem oriented policing by coordinating large scale cleanup projects; assist with homeless camp cleanup; provide logistic and manpower support to CSPD in disaster areas; and work enforcement areas in identifying high crime areas.

**Competencies Required:**

Human Collaboration Skills: Decisions regarding interpretation of policies may be made. Contact may involve support of controversial positions or the negotiation of sensitive issues or important presentations. Contacts may involve stressful, negative interactions with the public requiring high levels of tact and the ability to respond to aggressive interpersonal interactions.

**Certifications and Licenses:** Must possess or be able to acquire the following certifications and/or licenses.

Certifications required in accordance with standards established by departmental policy.

**Supervision Exercised:**

Work requires the occasional direction of helpers, assistants, seasonal employees, interns, or temporary employees.
