Class Specification – Street Programs Supervisor

Summary Statement: The purpose of this position is to provide professional program management and coordination of annual roadway resurfacing, concrete and drainage maintenance projects for both City and contracted programs. This is accomplished by planning and coordinating roadway resurfacing, concrete, and drainage projects; managing service and supply contracts; financial planning and budget management for the City and the Pikes Peak Rural Transportation Authority. Other duties include maintaining the street division equipment inventory and acts as a liaison for the streets division.	
Essential Functions	Note: Regular and predictable attendance is an essential function in the performance of this job.
Time % (All below must add to 100%)	Note: Time spent on each essential function will vary based on operational needs and is only intended to be an approximation over the course of a full year.
45%	Performs program planning and project supervisory duties by supervising staff for planning, implementing, and tracking of annual programs; developing, planning, and managing annual and multi-year concrete and resurfacing programs; maintaining PMA system by annual data collection and download onto the Cartegraph database; assigning work orders for projects that are associated with annual programs; invoicing of external projects; coordinating programs with City departments and outside agencies; and attending regularly scheduled and periodic meetings.
25%	Performs supervision and oversight of staff inspections by supervising staff for day-to-day roadway and drainage infrastructure maintenance operations; approving timesheets and expectations; directing the gathering of real-time data for the PMA system; and ensuring compliance with City standards specifications.
20%	Performs financial planning and budget management by managing and tracking material budget and ventures; developing and managing services and supply contracts; tracking and approving invoices; and estimating yearly program and individual project costs.
5%	Performs emergency responses by coordinating with afterhours emergency crews; coordinating with winter storm crews; monitoring contracted services; and coordinating crew response for summer storm events.

Human Collaboration Skills: Decisions regarding interpretation of policies may be made. Supervision Exercised:

Work requires supervising and monitoring performance for a regular group of employees or department including providing input or hiring/disciplinary actions and work objectives/effectiveness, performance evaluations, and realigning work as needed. A first line supervisor typically performs these functions.

Supervision Received:

Receives Direction: This job title normally performs the duty assignment after receiving general instructions as to methods, procedures, and desired end results. There is some opportunity for discretion when making selections among a few, easily identifiable choices. The assignment is usually reviewed upon completion.

Fiscal Responsibility:

The job title prepares accounting, budget, employment actions, and purchasing documents; and does research to justify language used in documents for a unit or division of a department. May recommend budget allocations.

Physical Demands:

Exerting up to 20 lbs. occasionally; 10 lbs. frequently; or negligible amounts constantly; OR requires walking or standing to a significant degree.
