Staff Updates

Special Improvement Maintenance Districts Update (Presented by John Gebhart, Special Improvement Maintenance Districts Unit Administrator)

John Gebhart, Special Improvement Maintenance Districts Unit Administrator, presented the Board with the Special Improvement Maintenance Districts (SIMD) update. This presentation included a map showing where the districts are located throughout the City; background on how SIMDs are formed and funded; Colorado Avenue Gateway SIMD; revenues and responsibilities of the Colorado Avenue Gateway SIMD; Platte Avenue SIMD; revenues and responsibilities of the Platte Avenue SIMD; the Platte Avenue corridor study; Woodstone SIMD; revenues and responsibilities of the Woodstone SIMD; Old Colorado City SIMD; revenues and responsibilities of the Old Colorado City SIMD; the Old Colorado City special district study; Stetson Hills SIMD; revenues and responsibilities of the Stetson Hills SIMD; Norwood SIMD; revenues and responsibilities of the Norwood SIMD; xeric bed renovations; Briargate General Improvement District (GID); revenues and responsibilities of the Briargate GID; erosion control project; updated GID map; SIMD/GID funding comparison; and finally, various SIMD challenges.

Staffing Update

Lonna Thelen, Design and Development Manager/TOPS Program Manager, announced that Daniel Gould has been selected as the Senior Landscape Architect, and will begin on November 13. Britt Haley, Director, announced that City Council has a Budget Work Session on Monday, where Department heads will present their recalibrated budgets to reflect the 3.43% reduction in the General Fund. Britt explained that one change for the Department is that Greyhawk Park will now be a two-phase approach for construction.
