Don't Delay... Reservations are accepted on a first-come, firstserved basis.

Payment is required at the time of booking.

Master Card, Visa, Discover and American Express can be used online or by phone. In-person with check, cash, or credit card.

NOTE: Park amenities require permit holder to provide their own sports equipment. Having a permit does not give exclusive use to any amenity.

General Questions

Small groups, under 50 people, can use parks on a first come, first served basis. All groups over 50 and those wishing to guarantee exclusive use of the pavilion, can reserve one of our designated locations.

Reservation hours coincide with park hours with the exception of American Mothers' Chapel.

Pavilion reservations at America the Beautiful Park and Bancroft Parks are only accepted with a Park Special Event permit. Please www.coloradosprings.gov/SpecialEvent for more details.

Bounce houses are NOT permitted with a pavilion reservation. If you would like to have a bounce house in a park, please see the Park Special Event application.

Please review all park rules listed on-site or in this brochure. Those caught in violation could be ticketed and/or fined.

- Tourists and other groups may be at the same site. Please be respectful of other park users.
- No receptions are allowed in the park unless you are at the Scotsman or South Spring Canyon picnic areas.

American Mothers' Chapel

The American Mothers' Chapel is located on Park property at the intersection of 31st Street and Chambers Way.

- Ceremony parking is only on Chambers Way
- · Chapel reservations do not apply to any other part of the including the parking lot.
- Under no circumstances may
- a motor vehicle park next to the Chapel or inside the Park fence line
- · There is a heater/air conditioner unit in the chapel for ceremony use.
- The Chapel is in a natural area. Do not release birds, butterflies, throw rice or confetti.
- · Flowers or other decorations should not be delivered early or left after use.
- No restrooms or changing areas on-site. Reservation Hours: 11 am-7 pm Maximum Capacity: 15 capacity; seats 12 American Mothers' Chapel: \$200/DAY

PARK RULES (ALL APPLY)

- · Alcoholic beverages are prohibited in City Parks by Ordinance No 9.9.410
- · Parking/Vehicular Access: Motorized vehicles of all types including golf carts, gators, ATVs, etc, are strictly prohibited on park property, lawns, turf, restricted roadway, bicycle/pedestrian pathways, canal, creek pathways, turf trail or athletic fields. All cars must be parked in designated parking areas.
- Trash and debris must be disposed of properly and area must be clean.
- · Open fires/charcoal grills are prohibited. Make every effort to see that propane grills are placed on hard surfaces such as a sidewalk or parking lot. If this is not possible, place a barrier, such as plywood, between the grass and the generator or grill to collect spillage of fuel or grease.
- It is unlawful for any person to injure, deface, destroy, sever or remove any park property.
- If you are using amplified equipment for your picnic or event, you will need to obtain a noise permit through the Police Department per Ordinances No 9.8.101 through 9.8.109. Please contact CSPD at (719) 444-7705 regarding noise permits. No special event permit is confirmed until the noise permit has been approved.
- The posting of signs leading to a reservation area or hanging decorations or other materials on park buildings, structures or vegetation is prohibited.

CITY POLICIES

Closing of Parks Ordinance (4.2.103) The City can close any park to protect the park land, park property/facility or to protect the public's health, safety or welfare. Should park closure happen, permit holders will be contacted immediately and a refund processed.


No Smoking Ordinance (6.6.202, 6.6.203 and 6.6.204) It shall be unlawful for any person to smoke, light, or carry any lighted smoking instrument in or on any park property.


Leash Ordinance (6.7.107, 9.9.302)

City code requires all dogs be on a leash while in city parks and on city trails. For designated off-leash dog parks or dog runs, visit coloradosprings.gov/DogParks

Rockets, Drones, or Model Aircraft (9.9.412)

It is unlawful for any unauthorized person to operate any rockets, drones, model airplanes, or radio controlled aircraft in any park except in areas set apart for these forms of recreation. Exception: Those having Special Event Permit and/or Commercial Film Permit. Those with permit must follow all FAA Rules and Regulations found at www.faa.gov/uas/
